2024 AEF Summer Public Interest Fellowships

AEF awards fellowships every year to law students who are committed to doing public interest work over the summer. Students must meet the following criteria:

- The public interest work must benefit either the Greater Washington, D.C. community-at-large, and/or the Asian Pacific American (APA) community.
- Eligible internship placements include federal, state, and local government; nonprofit organizations; District Attorney and Public Defender Offices; and judicial internships.
- The internship itself must be unpaid (except for nominal payment for items such as transportation, and other grants, fellowships, or funding).
- The internship must be at least eight weeks, or a total of 320 hours.

This year, AEF will award the following fellowships:

- **Robert E. Wone Fellowship:** AEF awards the Robert E. Wone Fellowship to one applicant each year. Created in 2007, this fellowship is awarded to the applicant who most embodies what a former director, Robert E. Wone, sought to be as a lawyer—a trusted member of the community, making a difference in public policies and seeing his efforts improve the circumstances of those around him. The winner of the Wone Fellowship will receive a total stipend of \$5,000 to \$6,000 (depending on funding).
- **AEF Public Interest Fellowships:** AEF awards Public Interest Fellowships to a selected few applicants each year. Each winner will receive a total stipend of \$3,000 to \$4,000 (depending on funding).

Fellows will receive a portion of their stipend at the beginning of the summer. The Fellows will then be responsible for completing the internship to the satisfaction of their employer. The Fellows must provide a written summary of the work performed, and submit their photo to appear in AEF's publications. Upon fulfilling these conditions, the Fellows will receive the remainder of the stipend.

Application Materials: Please submit the following items to applications@aefdc.org:

- (1) Application Form (see pages 3-4);
- (2) Employer Form (see pages 5-6);
 - If interning for more than one employer, please submit a form for each employer.
- (3) Resume;
- (4) Personal Statement under 500 words, explaining:
 - Your upcoming internship and how it will benefit the Greater Washington, D.C. community-at-large, and/or the Asian Pacific American (APA) community;
 - Your past or present activities showing commitment to the public interest and/or the APA community; and
 - Your connection to the Greater Washington, D.C. area.
 - **Please note that the Personal Statement carries great weight in the evaluation of your application.*
- (5) Law School Transcript; and
- (6) An Optional Letter of Recommendation.
 - You are welcome to submit a letter of recommendation. This can be from a non-lawyer or a lawyer; anyone who knows you from a professional, extracurricular, volunteer, and/or academic setting would be appropriate. The letter should be limited to one page in length. We encourage letters that speak to your public interest experience and/or interest.
 - **Please note that the letter of recommendation is completely optional.*

Format: Applications must be submitted in one single PDF file, labeled as “Your first and last name, 2024 Fellowship Application.” Items (1)–(5) must be organized in the order delineated above. The optional letter of recommendation may be emailed separately by your recommender, or combined directly with the application.

Deadline: Application materials must be received by **11:59 PM ET, on Monday, April 1, 2024.**

Interview: You may be contacted for a 20-minute interview with the AEF Board of Directors. Interviews will likely be held on **Tuesday April 9** or **Thursday April 11**, at **6-8 PM ET**.
