BIOGRAPHIES

OPENING REMARKS

The Honorable Laura A. Cordero was appointed to the District of Columbia Superior Court in 2005. Judge Cordero was born and raised in Chicago, Illinois, and attended DePaul University in Chicago, Illinois, where she earned a Bachelor of Arts in Political Science and a Bachelor of Arts in Mathematics in 1985, with highest honors. She earned her law degree from Harvard Law School in 1988.

Judge Cordero's dedication to public service spans her legal career. Following graduation from law school, she served a two-year term as law clerk to the Honorable James A. Parker of the United States District Court for the District of New Mexico. In 1991, Judge Cordero joined the Department of Justice under the Attorney General's Honor Law Graduate Program, where she was assigned to the Voting Section of the Civil Rights Division. In 1993, Judge Cordero joined the United States Attorney's Office for the District of Columbia. During her twelve-year tenure as an Assistant United States Attorney, she prosecuted a wide variety of criminal cases in the Superior Court for the District of Columbia, the District of Columbia Court of Appeals, the United States District Court for the District of Columbia, and the United States Court of Appeals for the District of Columbia Circuit. In



1999, she was assigned as the first Community Prosecutor stationed at the Metropolitan Police Department Third District, as part of the United States Attorney's Office city-wide Community Prosecution Program.

Prior to her appointment to the bench, Judge Cordero was the Executive Assistant United States Attorney for External Affairs. She was responsible for developing, coordinating, and maintaining effective partnerships with federal and local law enforcement, government agencies, and the community in the District of Columbia. She also coordinated an extensive community engagement network, involving a full range of community-based programs and initiatives for youth and adults specifically aimed at reducing violent crime in the District of Columbia.

Judge Cordero currently serves as the Deputy Presiding Judge of the Probate and Tax Division, handling decedent's estates, intervention proceedings, trusts, and tax cases. Judge Cordero has served twice in the Civil Division, most recently (2017 - 2020) as Presiding and Deputy Presiding Judge of the Civil Division. Both during her recent term and in 2010 - 2014, Judge Cordero presided over a broad range of civil suits, including medical malpractice, contracts, and torts. In 2016, she served as the Presiding Judge of the Domestic Violence Unit, while presiding over domestic violence misdemeanors. In 2015, she presided over requests for Civil Protection Orders in domestic violence cases. She has also served in the Family Court, handling cases involving abuse and neglect, adoptions, divorce, custody, child support, juvenile delinquency, juvenile drug court, and involuntary civil commitments for persons diagnosed with mental illness. Judge Cordero currently serves as a faculty member for Harvard Law School's Trial Advocacy Workshop, as a faculty member for the National Institute for Trial Advocacy, and as a Board Member of the Harry S. Truman Scholarship Foundation.

The Honorable Zuberi Bakari-Williams

is on a mission to inspire, empower, and provide opportunities for young people of color, women, and different sexual orientations to make the heart of the judicial system better and fairer. At the age of 36, he became one of the youngest judges in Maryland history and has not slowed down one bit.

Since taking the bench, he has won a litany of state and national awards, including the National Bar Association's Top 40 Under 40, the Maryland Daily Record's VIP List of Most successful by 40, the Leadership Center of Excellence's Top 40 Under 40



trailblazers in the DC Metro Area, and is recognized as a Top Leader in the Law in the State of Maryland.

Judge Williams is probably best known by law students for offering one of the most competitive and intense bootcamp summer internships in the nation. He trains law students in the practice of law, developing their scholarship writing, and investing in their futures to change the world. He single-handedly partnered with Microsoft, Facebook, Discovery Channel, and Under Armour, to allow his interns to have authentic conversations with legal decision-makers regarding career paths and learning what excellence looks like to them.

Judge Williams earned his Bachelor of Business Administration degree in Marketing from Texas Christian University (TCU) and received his JD/MBA joint degree from American University's Washington College of Law (WCL) and Kogod School of Business, respectively. He is an Adjunct professor at American University's Washington College of Law and the School of Public Affairs (undergraduate). He served as a judicial law clerk to both Chief Judge Robert M. Bell, Maryland Court of Appeals, and U.S. District Court Judge Gerald Bruce Lee, Eastern District of Virginia. He was an Attorney at Venable LLP and was an Assistant Attorney General for the District of Columbia.



The Honorable Wayne A. Brooks is an Associate Judge in the District Court of Maryland, District 10, Howard County since June 13, 2014. He has served as a member of the Specialty Courts and Dockets Committee and currently serves on the ADR Sub-committee, Civil Law Legislative Sub-committee, and Mental Health, Alcoholism and Addictions Subcommittee. Judicial Council.

His other professional legal positions include the following: United States Army Judge Advocate General's Corps (Captain, 1985-87); Special Assistant U.S. Prosecutor, U.S. Magistrate Court, 1985-86; Associate; Fossett & Brugger, Chartered, 1987-90; Alfred Nancy & Associates, 1990-91; Law Offices of James H. Taylor, P.C., 1991; Hearing Officer, Department of Environmental Resources, Prince George's County, 1991; Assistant Public Defender, Mental Health Division, Howard County, 1991-94; Executive Administrative Law Judge and Deputy Director of Operations, Office of Administrative Hearings, 2001-14 (Administrative Law Judge, 1995-2001).

Judge Brooks earned his Bachelor of Science in Psychology from Howard University and his JD from University of Maryland School of Law.

The Honorable Kenia Seoane López is currently a Magistrate Judge in the Superior Court of the District of Columbia. Before being appointed as a Magistrate Judge in 2012 she served as a Bilingual Attorney Negotiator in the Domestic Violence Division of the District of Columbia Superior Court. Prior to joining the Court, she was an Assistant Attorney General in the Legal Services Section of the Child Support Division in the Office of the Attorney General for the District of Columbia. Magistrate Judge Seoane Lopez served as a Law Clerk to the Massachusetts Superior Court and the Superior Court of the District of Columbia. She is a 2002 graduate of the University of Wisconsin Law School. In 2002, she also received a Masters of Arts from the University of Wisconsin Graduate School in Latin American, Caribbean, and Iberian Studies. She graduated Cum Laude from Northeastern University in Boston, Massachusetts with a Bachelor of Science in Criminal Justice. She served as the President of the Hispanic Bar Association of the District of Columbia. Magistrate Judge Seoane López is the current Chair



of the Hispanic Bar Association of the District of Columbia Judicial Council.

The Honorable Shelly A. Mulkey has served as Magistrate Judge on the D.C. Superior Court since October 31, 2016.

Judge Mulkey received a Bachelor of Arts degree in Sociology from Tulane University and her law degree from the American University, Washington College of Law in 2001. Judge Mulkey is a former Dean's Fellow for Professor David E. Aaronson. Following law school, Judge Mulkey clerked for the Honorable Eric M. Johnson, Sixth Judicial Circuit of Maryland. She was previously an Assistant Attorney General in the Child Support Services Division of the Office of the Attorney General for the District of Columbia and an associate attorney at the Law Offices of Alice Paré.

Judge Mulkey is currently assigned to the Criminal Division. In the Criminal Division, she handles local criminal matters including

arraignments, preliminary hearings, and misdemeanor trials. Previously, Judge Mulkey was assigned to the Family Court, where she handled cases involving child abuse and neglect, adoption, guardianship,

divorce, custody, parentage, child support, and juvenile delinquency. She has also served in the Domestic Violence Division, where she conducted ex parte hearings on petitions requesting temporary protection orders.

Judge Mulkey serves on several D.C. Superior Court committees, including: Committee on Public Education and Court Independence; Committee on Security; and Committee on Criminal Justice Act Panel Attorneys, Continuing Education for Panel Attorneys, and CJA Investigators. She serves as Secretary of the Hispanic Bar Association's Judicial Council. Judge Mulkey previously served as a co-chair of the D.C. Superior Court's education working group, participated on the D.C. Superior Court's Committee on Abuse & Neglect Proceedings, D.C. Superior Court's Committee on Paternity & Support Proceedings, and was a member of the Preparing Youth for Adulthood Committee. Judge Mulkey previously served on the D.C. Child Support Guideline Commission. She is an active member of the Women's Bar Association of the District of Columbia and the Hispanic Bar Association of the District of Columbia, where she mentors attorneys and law students. Judge Mulkey is a former mentor at Mentors, Inc.

FEDERAL DISTRICT COURT PANEL

Distinguished Panelists

The Honorable George J. Hazel was born in Queens, NY in 1975. He graduated from Morehouse College in 1996 and from the Georgetown University Law Center in 1999. Judge Hazel began his legal career at the law firm of Weil, Gotshal & Manges LLP in Washington, DC from 1999 to 2004. He served as an Assistant United States Attorney in the District of Columbia from 2005 to 2008 and in the District of Maryland from 2008 to 2010 where he served as Southern Division coordinator for Project EXILE. From 2011 until his appointment to the bench, Judge Hazel served as Chief Deputy State's Attorney for Baltimore, Maryland. On September 25, 2013, President Barack Obama nominated Judge



Hazel to serve as a United States District Judge. On May 1, 2014, the United States Senate confirmed his nomination and he received his judicial commission on May 2, 2014.



The Honorable Theodore D. Chuang serves as a United States District Judge for the District of Maryland and sits at the United States Courthouse in Greenbelt, Maryland, near Washington, D.C. Judge Chuang was appointed by President Obama in May 2014 and is the first Asian American Article III federal judge to serve in any of the states within the Fourth Circuit.

Prior to his appointment, Judge Chuang served as Deputy General Counsel of the U.S. Department of Homeland Security (DHS) from 2011 to 2014 and as Associate General Counsel of DHS from 2009 to 2011. In 2009, he served as Chief Investigative Counsel for the U.S. House of Representatives, Committee on Energy and Commerce. From 2007 to 2009, he served as Deputy Chief Investigative Counsel for the House Committee on Oversight and Government Reform. From 2004 to 2007, Judge Chuang was in private practice in Washington, D.C. at Wilmer Cutler Pickering Hale and Dorr, LLP. From 1998 to 2004, Judge

Chuang served as an Assistant United States Attorney in the Criminal Division of the U.S. Attorney's Office for the District of Massachusetts. From 1995 to 1998, he served as a trial attorney at the U.S. Department of Justice, Civil Rights Division, in Washington, D.C. Judge Chuang began his legal career as a law clerk to Judge Dorothy W. Nelson of the U.S. Court of Appeals for the Ninth Circuit.

Throughout his career, Judge Chuang has been active in professional and community organizations. He has served on the Board of Governors of the District of Columbia Bar and is a member of the American Law Institute. He has also served as Chair of the Board of Directors of the Asian Pacific American Legal Resource Center, a legal services organization serving low income, limited English proficient Asian

Americans and immigrants in Maryland and the Washington, D.C. region; as President of the Asian American Lawyers Association of Massachusetts, from which he received the 2018 Founders Award; as President-Elect of the Asian Pacific American Bar Association of the Greater Washington, D.C. Area, from which he received the 2019 Pioneer Award; and as an Advisor to the Board of Directors of the Asian Pacific American Bar Association of Maryland.

Judge Chuang graduated *magna cum laude* from Harvard Law School in 1994, where he was an Editor of the Harvard Law Review and a Finalist in the Ames Moot Court Competition, and received his B.A. *summa cum laude* in Economics from Harvard University in 1991.

The Honorable Zia M. Faruqui has been serving as a federal magistrate judge for the District of Columbia since September 2020. Prior to his appointment, he was a federal prosecutor, first in the United States Attorney's Office for the Eastern District of Missouri and then in the District of Columbia. Over the span of over twelve years of federal service as an AUSA, he prosecuted numerous criminal cases, most recently serving as the lead prosecutor for complex and novel crimes involving, for example, terrorists' use of cryptocurrency, nuclear weapons proliferation, darknet sites dedicated to child exploitation, and antiquities theft. He also litigated over \$700 million in money laundering and asset forfeiture proceedings. As a subject-matter expert, he has presented on cryptocurrency and anti-money laundering issues in conferences spanning from Europe to Asia and the Middle East. Prior to serving as a federal prosecutor, Judge Faruqui worked at a corporate law firm where he focused on government investigations and general commercial litigation. Judge Faruqui is a board member



for Jobs for Homeless People, a non-profit that provides housing and vocational training to people in the D.C. metropolitan area. He also served as a Muslim-outreach coordinator for the Department of Justice and an as an adjunct professor at Harris-Stowe State University. He received his J.D. and undergraduate degree from Georgetown University.

Before joining the firm, he served as a law clerk to the Honorable Brian M. Cogan of the U.S. District Court for the Eastern District of New York. Mr. Wone previously worked as a law clerk for the Honorable Richard W. Roberts, United States District Court for the District of Columbia. He graduated with a B.S. from Cornell University and a J.D., magna cum laude, from the University of Illinois College of Law.

Rothstein of the United States District Court for the Western District of Washington. She also worked at Cozen as a law clerk during her last year of law school. From 2012 to January 2017, he served as an associate general counsel for the Office of the General Counsel, Executive Office for Immigration Review (EOIR), Department of Justice (DOJ), in Falls Church, Va. From 2010 through 2012, he served as an attorney advisor for the Office of Legal Policy, DOJ, in Washington, D.C. From 2006 through 2010, he served as an attorney advisor for the Buffalo Immigration Court, EOIR, DOJ. Judge Soper is a member of the Oregon State Bar.

The Honorable Sun Choi was appointed as an Administrative Law Judge with the Maryland Office of Administrative Hearings, in March 2021. She graduated from the University of Virginia with a B.S., in Commerce and a J.D., from American University, Washington College of Law. Upon graduation, Ms. Choi served as a judicial law clerk to the late Chief Judge Eugene N. Hamilton of D.C. Superior Court in Washington, D.C., and then served as a prosecutor at the State's Attorney's Office for Frederick County, Maryland. 

The Honorable Patricia A. Millett was appointed to the United States Court of Appeals for the District of Columbia Circuit on December 10, 2013. She graduated from the University of Illinois at Urbana-Champaign, summa cum laude, in 1985 and from Harvard Law School, magna cum laude, in 1988. After working in a private law firm (Miller & Chevalier) for two years, she clerked for Judge Thomas Tang of the United States Court of Appeals for the Ninth Circuit. Following her clerkship, she worked for four years on the Appellate Staff of the Civil Division in the United States Department of Justice and for eleven years as an Assistant in the Office of the Solicitor General. In September 2007, she became a leading partner in the Supreme Court and appellate practices at Akin Gump Strauss Hauer & Feld LLP. She has argued 32 cases before the U.S. Supreme Court.





The Honorable Raymond T. Chen was appointed to the United States Court of Appeals for the Federal Circuit by President Barack H. Obama in 2013, confirmed by the Senate on August 1, 2013 and assumed his office on August 5, 2013.

Judge Chen served as Deputy General Counsel for Intellectual Property Law and Solicitor at the United States Patent and Trademark Office from 2008 to 2013. He was an Associate Solicitor in that office from 1998 to 2008. From 1996 to 1998, Judge Chen served as a Technical Assistant at the United States Court of Appeals for the Federal Circuit. Before joining the court staff, Judge Chen was an associate with Knobbe, Martens, Olson & Bear from 1994 to 1996. Before entering law school, Judge Chen worked as a scientist at the law firm of Hecker & Harriman from 1989 to 1991.

Judge Chen received his J.D. from the New York University School of Law in 1994 and his B.S. in Electrical Engineering from the University of California, Los Angeles in 1990.

The Honorable Daniel Ortiz serves as a Court of Appeals of Virginia judge after being elected September 1, 2021, for an eight-year term. Prior to his current judicial post, Judge Ortiz served as a Fairfax County Circuit Court judge for almost seven years.

Understanding the importance of making the legal system available to everyone, he has shaped his legal career around a commitment to public and community service, even while working in private practice. He first saw the need for a more equitable system when he started his legal career clerking for

He previously served as a substitute judge in the General District Court and Juvenile and Domestic Relations District Court for five years. In 2013, he received a Golden Gavel from the Fairfax Law Foundation, acknowledging his charitable community work. Judge Ortiz also received the Virginia Bar Association's Emerson G. Spies and Sandra P. Thompson Awards for his outstanding work, dedication, and service to the bar association.

Judge Ortiz completed his undergraduate studies at the University of Virginia and received his law degree from the George Washington University Law School.
